



A Substantial Amendment to Hillsborough County's FY 2007-08 & 2010-11 Action Plans

Hillsborough County proposes to amend the FY 2007-08 and 2010-11 Annual Action Plans. The Action Plans guide the County on how it will spend grant funds received from the United States Department of Housing and Urban Development (HUD). The Community Development Block Grant (CDBG) funds will be impacted by the changes proposed in this amendment. The amendment establishes three new activities to include Interim Assistance, Park Improvements and Property Acquisition and re-program funds for these activities. The proposed budget changes are provided below.
