## TOILET REBATE APPLICATION

Prior to 1995, the plumbing code allowed the production of toilets that used over 3.5 gallons of water per flush (GPF), but today's models use 1.6 GPF or less. You can conserve water by replacing older high-volume toilets with new ultra-low-flow toilet (ULFT) models, a 20,000 gallon per year savings for the average household! This should lead to a decrease in your water bill, plus you could start saving instantly with a rebate of up to \$270 from Hillsborough County. [Water](#) you waiting for?

**TERMS AND CONDITIONS**

Up to three (3) one-time toilet replacements are eligible for rebate spanning the property's historical record of existence, contingent on the number of bathrooms at said property, at or below three (3). Rebates are not given for replacement of pre-existing ULFTs. Commercial, non-residential property rebates are limited by the number of fixtures. If the purchase price of the ULFT and parts plus tax is less than the purchase allowances listed in the table above, you will receive the lesser amount. Parts include: the tank, bowl, wax ring, plumbing parts, and bolts. Parts do not include toilet seats. To qualify for the Installation Allowance, receipt(s) for ULFT installation must show work was performed by a licensed plumber and indicate the license number. You should receive a rebate check by mail within six to eight weeks after submission of completed application and receipt(s). All rebates are subject to verification inspection. Rebates are issued to the property owner or duly authorized managing agent only. All correspondence is made to the property owner or duly authorized managing agent only. Funds are limited and available on a first come, first served basis. This program is only available to potable water customers of Hillsborough County Public Utilities Department, not water customers of the cities of Plant City, Tampa, or Temple Terrace, nor any franchise or private utilities. Also not available to self-supplied well users. Note: Hillsborough County does not sell or install toilets, nor do they make any specific guarantee on toilet performance. Toilet performance varies, so choose your new toilets carefully.
