Hillsborough County deems all bid proposals to have been proffered in recognition and consideration of the entire bid package - including all issued addenda. For purposes of clarification, receipt of this present Addendum by a **Bidder should be evidenced by returning it (signed) as part of the Bidder's sealed bid proposal.**

THE INFORMATION INCLUDED HEREIN IS HEREBY INCORPORATED INTO THE CONTRACT DOCUMENTS OF THIS PRESENT BID MATTER AND SUPERSEDES ANY CONFLICTING CONTRACT DOCUMENTS OR PORTION THEREOF PREVIOUSLY ISSUED:

REASON FOR ISSUANCE OF THIS ADDENDUM:

1. Issue changes to the contract title adding "Level A" to the end of the title.
2. Page SC-10, paragraph 2.1.2 is modified to add the words "or Certified Building Contractor." First sentence to now read *The Contractor shall be a licensed General Contractor or Certified Building Contractor who has satisfied all state and local requirements to be actively engaged in contracting.*
3. Page SC-5, paragraph 1.09.5 has been modified to include a wording change in the first sentence and to add a new second sentence as follows:

Because the intent of this solicitation is to provide additional capacity, companies holding existing miscellaneous construction contracts with Hillsborough County using RS Means will NOT be eligible for award. However, companies with an existing miscellaneous construction contract expiring on or before April 5, 2010 will be eligible for award. Additionally, companies which have the same corporate officers and companies whose majority interest is held by the owner of a company that has an existing miscellaneous construction, using RS Means, contracts with Hillsborough County are NOT eligible for award.
