ULTRA LOW FLOW TOILET REBATE PROGRAM

Install a ULF Toilet and you'll save more than just money. Conserving our water resources is one of the most important issues facing the world today. With only one percent of the Earth's water available to humanity and nature, it is paramount that we all help conserve our water. One of the easiest ways to do this is to replace older high volume toilets with new ultra low flow models. Prior to 1993, the plumbing code allowed the installation of toilets that flushed with 3.5 gallons or more. Since 1993 the plumbing code specifies a maximum 1.6 gallon per flush standard. Today, toilets are even available at as little as 1.28 gallons per flush. Family water use varies, but by making this change, the average household could save 20,000 gallons of water per year! This could lead to a significant reduction in the household's water bill, plus, you can start saving instantly with up to a \$150 rebate from Hillsborough County. **This program is only available to water customers of Hillsborough County Water Resource Services.**

Here's how it works:

- **Contact Water Resource Services at 274-6800, extension 43985 to check for previous installations and program participation eligibility.**
- Fill out the attached Rebate Application and send along with the original sales receipt(s) listing separate costs for the ULF toilet, parts and labor.
- Mail forms to Water Resource Services, ULF Toilet Rebate program, 925 E. Twiggs Street, Tampa, FL 33602.
- If you would like your sales receipt returned, enclose a self-addressed, stamped envelope. Include the original receipt from your licensed plumber if you wish to receive the installation allowance.
- Send only one application for each service address, no matter how many units are installed. (program not available for new construction since 1993).
- You must agree to participate in a water conservation survey and a random, on-site installation verification. You may be contacted by the rebate program administrator to schedule an on-site installation verification inspection.
- **Hillsborough County does not sell or install toilets, nor do they make any specific guarantee on toilet performance. Toilet performance varies, so choose your new toilets carefully.**

Rebate Amounts:

You should receive your rebate check by mail in six to eight weeks after submitting a complete application, Supplemental W-9 form and receipts. If the purchase price of the ULF toilet is less than the rebate amounts listed below, you will receive a rebate equal to the purchase price. Fixture costs include: the tank, bowl, wax ring, plumbing parts and bolts. **Toilet seats are not eligible.** If the ULF toilet is installed by a licensed plumber, you may apply the installation allowance toward a portion of the installation cost.

Single-Family Homes, Resident-Owned Condos and Mobile Homes

Toilets	Maximum Rebate	Installation Allowance	Total
1 st	\$ 125	\$ 25	\$ 150
2 nd	\$ 65	\$ 15	\$ 80
3 rd (maximum)	\$ 40	none	\$ 40

A maximum of three toilets to be rebated per single family dwelling. Maximum rebate for three toilets is \$270.

Commercial Properties, Business Apartments, Duplexes, etc.

Rebates are available at a maximum of \$100 per replaced toilet, with no limit on the number replaced on each property; however, all such rebates are subject to installation verification inspection. No installation allowance is available.
