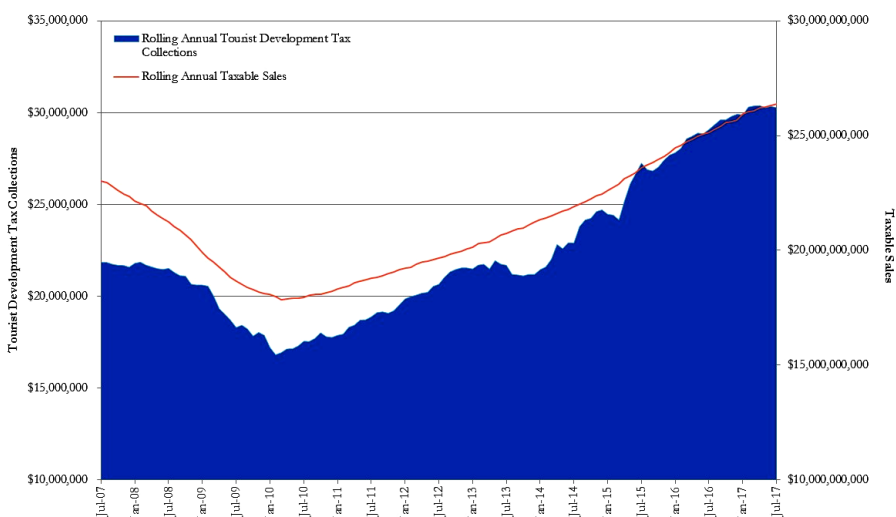
Home Sales In August 2017, Hillsborough County had total of **1,917** closed sales for single family homes. In August 2016, the total was 1,767 closed sales. That is an 8.5% increase in closed sales for single family homes.

In August 2017, Hillsborough County had a total of **558** closed sales for townhouses and condos. In August 2016, the total was 478 closed sales. That is a 16.7% increase in closed sales for townhouses and condos.

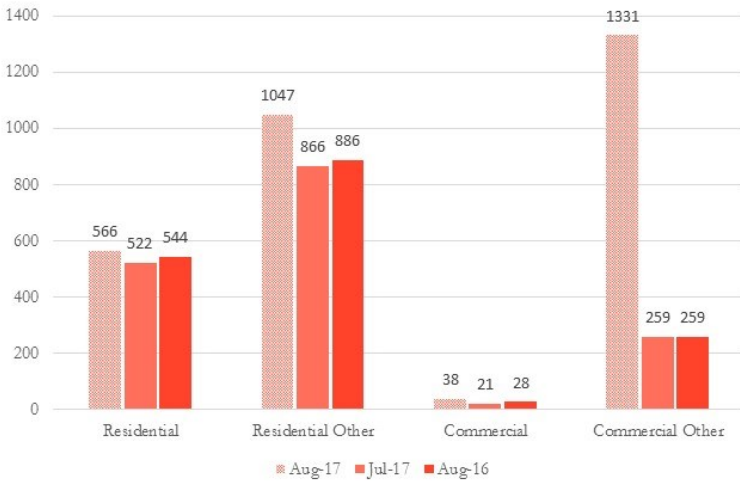

Hillsborough County Gross and Taxable Sales

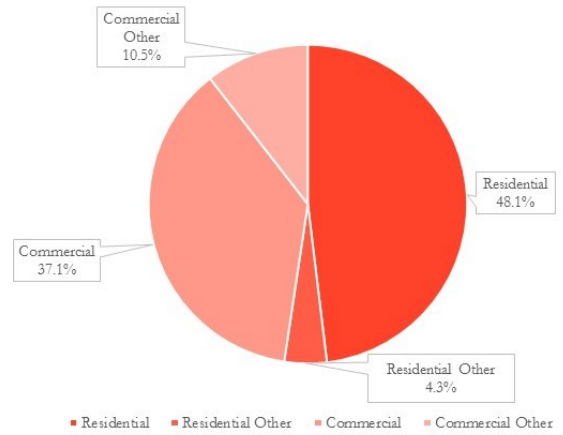
