


Quarterly Economic Indicators Report—June 2017

The big story in the second quarter of 2017 is unemployment. Hillsborough County's quarterly unemployment rate is under 4 percent for the first time since the recession. In fact, the lowest monthly unemployment rate over the last decade occurred in May 2017. The quarterly rate of 3.8 percent is a far cry from the 10-year average of 7.2 percent. In other economic news, new commercial building permits saw a large increase this quarter and international passengers at Tampa International Airport continued to climb with new international destinations arriving. All in all, Hillsborough County continues to show steady growth in this post-recession economy.



Quarterly Focus—Small & Minority Business Programs in Hillsborough County

Hillsborough County runs two programs designed to help both **Disadvantaged Minority/Disadvantaged Women Businesses (DM/DWBE)** and **Small Business Enterprises (SBE)** participate in the County's procurement programs, which include construction, contractual services, professional consulting services, and commodities.

The **SBE Program** provides many benefits, resources, and opportunities for SBE registered firms. Hillsborough County's SBE program is designed for independently owned and operated businesses that have 25 or less employees and are primarily domiciled in Hillsborough County. Annual gross incomes for businesses interested in the SBE program should not exceed \$3 million. Capital construction projects that are less than \$500,000 may be set aside for bidding by already registered companies. Purchases of contractual services, commodities, and professional consulting services may also be set aside for competition among registered firms. Periodic seminars and workshops are also conducted for firms to assist them through this process.

The **DM/DWBE Program** is for companies whose management and daily operations are in control of a qualifying minority or woman. This person must also own 51 percent of the company and hold any applicable professional licenses (depending on the industry). The net worth of the business should be less than \$2 million and the business should have 50 employees or less. For the purposes of the DM/DWBE program, eligible minority groups are African American, Hispanic, Asian American, and Native American. Participants in the DM/DWBE program get the same benefits that are provided for bidding and purchases through the SBE program. The DM/DWBE program also allows for reciprocity for firms who are located in the state of Florida and certified by their local jurisdiction within the state.

Hillsborough County's DM/DWBE and SBE Programs by the numbers

- There are 771 firms currently certified with Hillsborough County's two programs
- Staff attended 25 events in FY17 to promote the two certification programs
- 19 workshops and education events were held for participants in the DM/ DWBE and SBE programs
- Staff has completed 45 construction site visits and 4 certification visits so far in FY17
- Staff has attended 25 pre-bid or preconstruction meetings in FY17
- There have nearly **300** contract reviews in FY17
