
Hillsborough County's economy continues to impress. In September 2018, the unemployment rate fell below 3% for the first time since April 2006. It is also the lowest it's been in more than 19 years. While unemployment plummets, the number of high-wage jobs in targeted industries is steadily increasing. Professional services, finance and insurance, and health care sector jobs have all added at least 1,800 jobs from the previous year. Tourism Development Tax is repeatedly breaking records. For calendar year 2018, the TDT collections have been over \$24 million, a 9.1% increase from the previous year. The TDT figures reinforce the airport's performance. Tampa International Airport has increased its passengers by over 11% from both its domestic and international flights. It certainly is a great time to be a resident in Hillsborough County.





# **Quarterly Highlight: Entrepreneur Collaborative Center**


