### Home Sales

In April 2020, Hillsborough County had a total of **1,529** closed sales for single family homes. In April 2019, the total was 1,873 closed sales. That is a -18.4% decline in closed sales for single family homes.

In April 2020, Hillsborough County had a total of **420** closed sales for townhouses and condos. In April 2019, the total was 538 closed sales. That is a -21.9% decrease in closed sales for townhouses and condos.

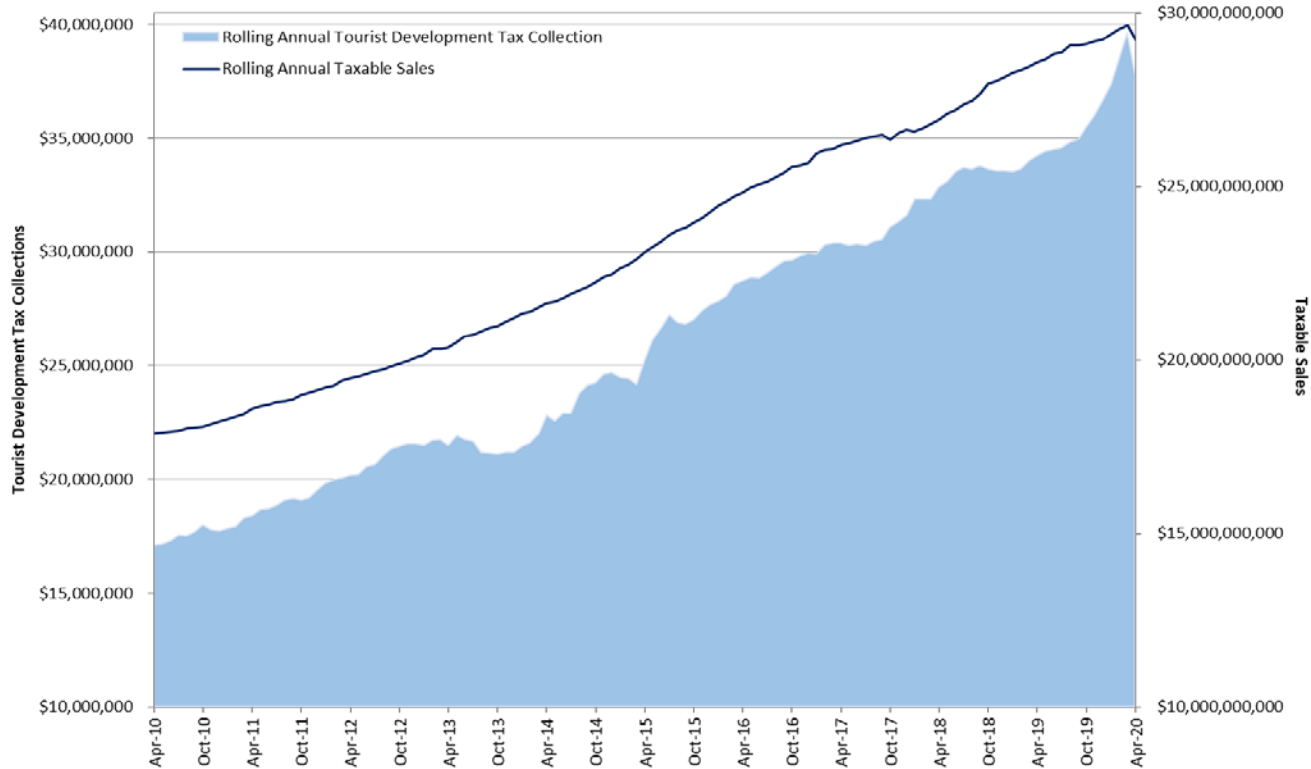
### Tourist Development Tax Collections

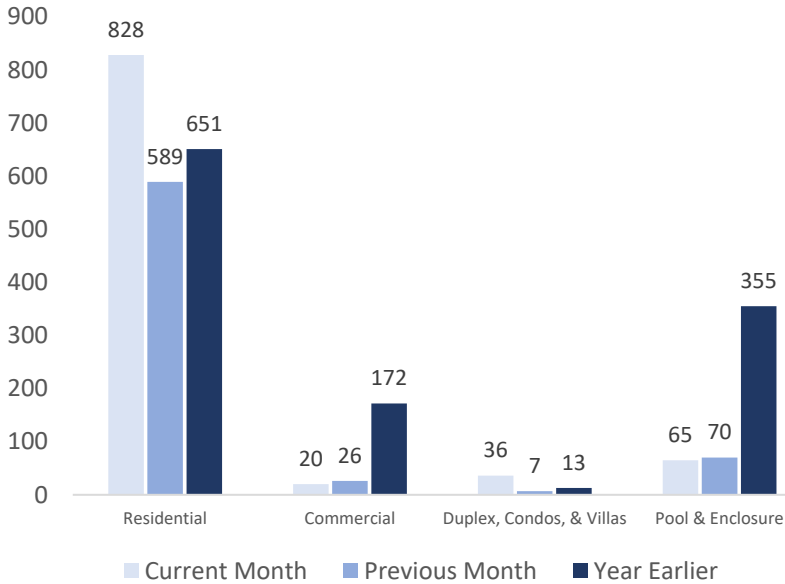

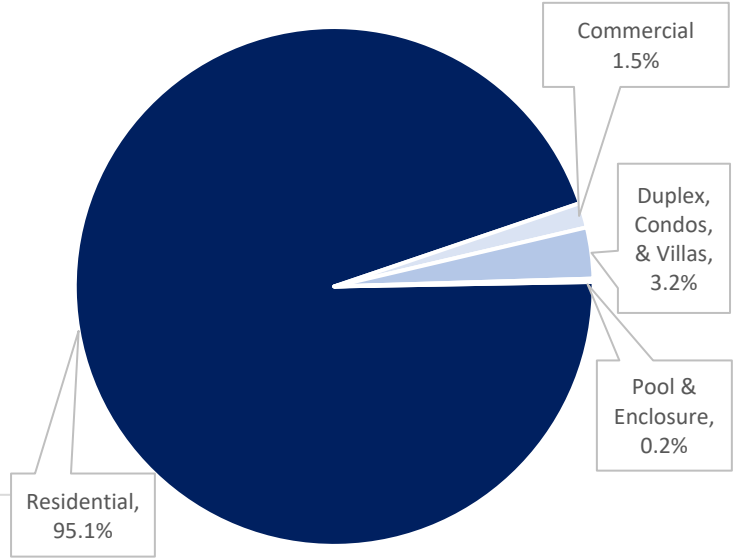
