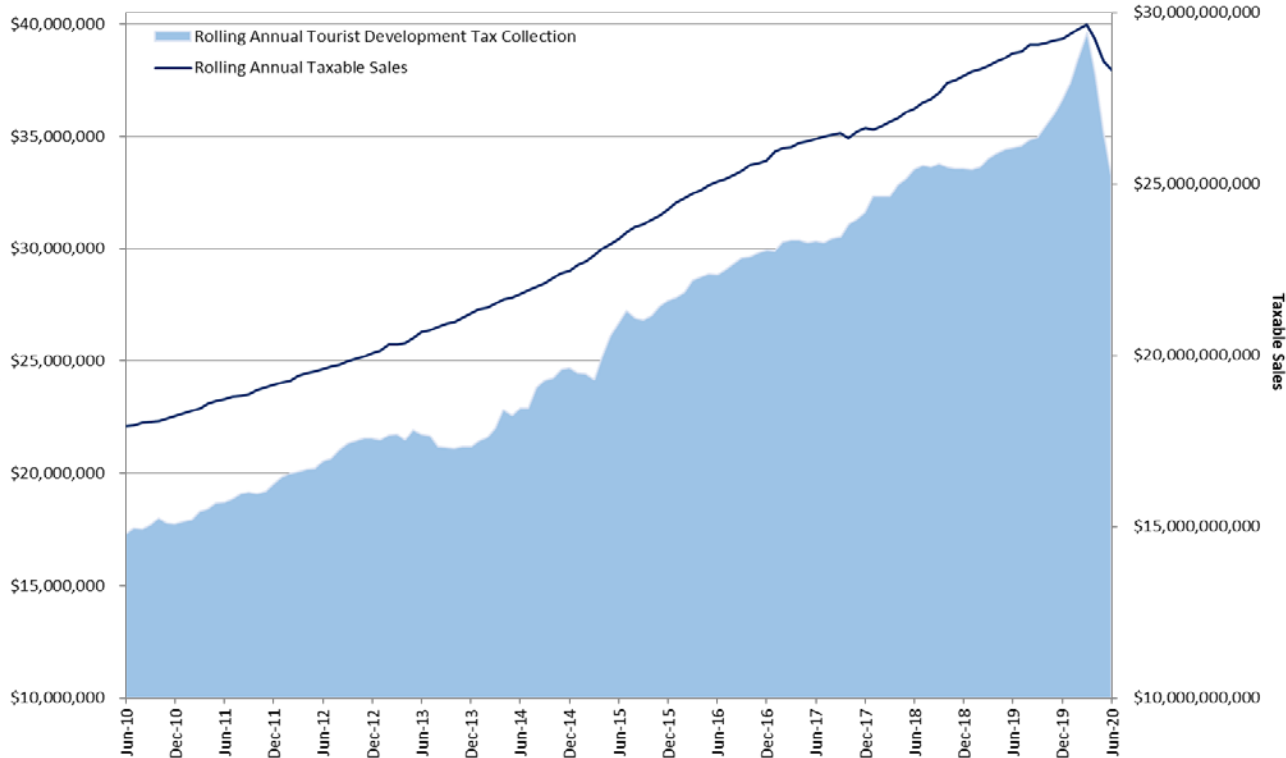
### Home Sales

In June 2020, Hillsborough County had a total of **2,089** closed sales for single family homes. In June 2019, the total was 2,077 closed sales. That is a 0.6% increase in closed sales for single family homes.

In June 2020, Hillsborough County had a total of **626** closed sales for townhouses and condos. In June 2019, the total was 523 closed sales. That is a 19.7% increase in closed sales for townhouses and condos.

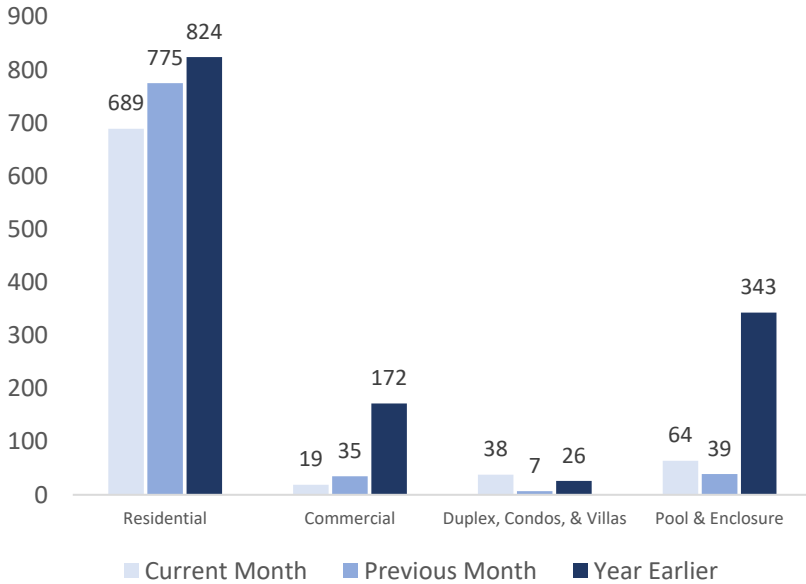

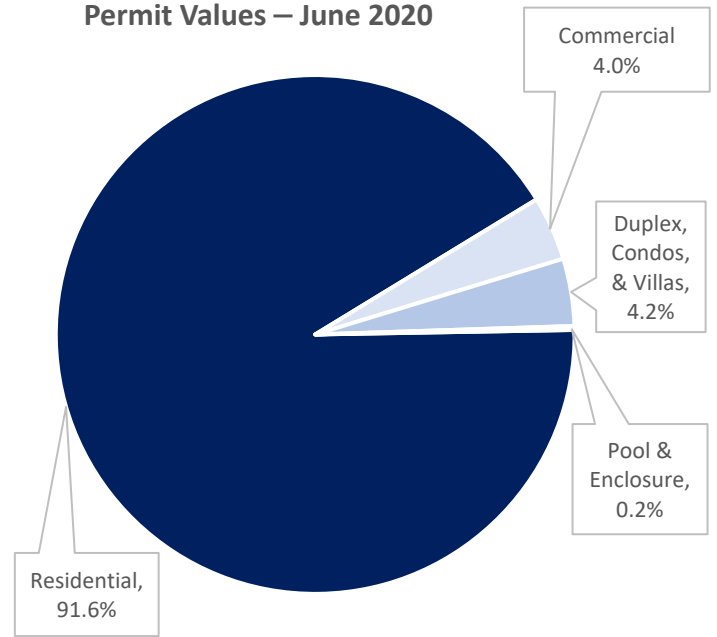
