Dear Ms. Bean:

This is in reference to a request that the Federal Emergency Management Agency (FEMA) determine if the structures described in the enclosed table are located within an identified Special Flood Hazard Area (SFHA), the area that would be inundated by the flood having a 1-percent chance of being equaled or exceeded in any given year (base flood), on the effective National Flood Insurance Program (NFIP) map. Using the information submitted and the effective NFIP map, we have determined that the structures are not located in the SFHA. The subject structures are correctly shown outside the SFHA located on the effective NFIP map; therefore, the Federal mandatory flood insurance requirement does not apply. **This determination supersedes our previous determination 08-04-6217A, dated August 29, 2008, for all subject properties.**

Because this LOMA will not be printed or distributed to primary map users, such as local insurance agents and mortgage lenders, your community will serve as a repository for this new data. We encourage you to disseminate the information reflected by this letter throughout your community so that interested persons, such as property owners, local insurance agents, and mortgage lenders, may benefit from the information.
